## 1. VENUE

NCUI Campus, 3, Siri Institutional Area, August Kranti Marg, New Delhi-16

## 2. DATES & DURATION

3rd - 5th March, 2011

Time : 10am - 8pm

## 3. PARTICIPATION CHARGES

Built up Stall : Rs. 3000/- per sq. mtr.

(Minimum 9 sq. mtr. & Multiples there of)

## 4. FACILITIES

### 4.1 Package of facilities for built up stalls: Back and side

partitions with prefab system similar to octonorm and PVC laminated panels, synthetic carpets, fascia in English with stall nos. written in uniform style, three spotlights per 9 sq. mtr. area, 5/15 amp. Socket-outlet, one table/counter and two chairs per 9 sq. mtr. stall booked and other basic facilities like security, general lighting and electricity consumption of the stall with standard fittings.

### 4.2 Basic facilities available for all exhibitors: General

decoration, security in exhibition hall, General Publicity for Visitor Promotion, General Illumination inside Exhibition Hall, Cleaning of Traffic Lanes, Passages, Open Space inside the Exhibition except the Exhibitors Stall, Aisles in the Exhibition Hall, Invitation for the inauguration function.

### 4.3 Additional facilities available on payment basis:

Electricity for additional lighting and power for demonstration of equipment. Additional Furniture, Spot Lights, Plug Points, Other Electrical Fittings, Fixtures, Wiring etc. Services of Official Stand, presentation agency for design/decoration work, display aids, stand attendant/interpreter/Girl Guides, Business Centre facilities such as Fax/Telefax/Photocopy/Typing etc. Services of official freight forwarding, handling and clearing agency. Catering service for Snacks, Lunch etc.

## 5. PARTICIPATION CHARGES (AS INDICATED IN CLAUSE-3 ABOVE)

The application form is to be signed and returned to National Yuva Cooperative Society Ltd. It must be accompanied with payment as indicated therein. Allotment of Exhibition stall is on First-come-first-serve basis.

## 6. LETTER OF PARTICIPATION

Letter of participation shall be issued to two officials per exhibitors after receiving full (100%) participation charges.

## 7. CO-EXHIBITORS AND SUBLETTING

Subletting of stalls is absolutely prohibited.

## 8. TECHNICAL GUIDELINES

If Exhibitors are particular about height to be more than 2.50mt. Written permission of the Organisers should be obtained on the appropriate plans. Exhibitors are required to comply with Instructions Issued by the Organisers regarding schedule for setting up and Dismantling stalls. Failure to comply with the instructions will attract penalty and Exhibitors are liable to pay the same.

## 9. GENERAL

The Exhibitor is liable for payment of compensation for any bodily harm to person, Staff/ Agent/ Organisers and other Exhibitors and/or damage caused to the property of the Organisers and other Exhibitors, caused by himself or his agents during transportation, installation, fair duration and dismantling period.

## 10. RIGHTS OF ORGANISERS

To reject any application for space without assigning reason.

To amend the terms and conditions for participation and issue additional rules and regulations for the exhibitors from time to time which shall be binding on the exhibitors.

To recover from the Exhibitors, compensation for losses/damages caused to the property or reasonable penalty for any willful contravention of the terms for participation.

To postpone, curtail, extend or abandon the exhibition or close some or all sections of it temporarily, if unforeseen circumstances so require. In such circumstances, the Exhibitors shall not be entitled to withdraw from the contract or claim any compensation or damage thereof.

To take photographs or video film of the interior of any stall and to use the same for promotional work.

To refuse permission to any Exhibitor to clear his stall if he has not paid all dues to the Organisers or to retain the exhibits or other goods as collateral security till dues are paid.

## 11. INSURANCE

Organisers shall not be responsible for any loss whatsoever incurred by exhibitors and they should obtain comprehensive insurance coverage for their exhibits against all risks for the periods covering transportations, preparation, installation, fair duration, dismantling, return and transit.

## 12. COUNTER SALES

Counter sales are permitted at the exhibition. Exhibitors can sell their exhibits/equipment. In the case of sale, the payment of sales tax, customs etc. as applicable, to the concerned authorities will be the direct responsibility of Exhibitors.

## 13. NON ALLOCATION, CANCELLATION NON PARTICIPATION

13.1 If the organisers cannot allot a stall, money paid by the prospective Exhibitor will be refunded.

13.2 If any Exhibitor withdraws or cancels participation 100% amount paid will be forfeited.

13.3 If any Exhibitor fails to turn up for setting up the stall by 10 00 hrs on March 3, 2011 or cancels his participation at the last moment, organisers shall utilize the stall in any manner they deem fit, forfeiting all the money paid by the Exhibitor.

## 14. FORCE MAJURE

Under the conditions of the Force Majeure, which also include strike, lock out, closure, Riots, the organisers reserve the right to alter the opening dates and duration or even cancel the entire exhibition. In case of change in dates and duration of exhibition the contractual obligation between the Organiser and the Exhibitors remain unaffected. In case of cancellation of the Exhibition, the stall rental will be refunded to the Exhibitors after deducting the proportionate costs already incurred by the organisers.

## 15. ARBITRATION

Disputes if any shall be subject to arbitration under the Indian Council of Arbitration at New Delhi.
